## **General Summary**

The Financial Planning & Analysis (FP&A) Manager is responsible for the management reporting, budgeting, forecasting, and economic evaluation processes and tools for Pin Oak Group, LLC ("Company"), preparing useful analysis of results and performance for the executive team and management in support of performance improvement. The FP&A Manager also supports the EVP of Strategy & Business Development to provide modeling and other meaningful analysis of growth opportunities.

# **Essential Functions**

- Manages development and use of budgeting, forecasting, and economic/valuation tools and models. Provides economic modeling support for Company strategic growth efforts, including organic investments and M&A activity
- Prepares monthly financial reports and quarterly performance review packages for company executives and board of directors
- Analyzes current and past trends in key performance indicators for all areas of revenue, expense, and capital investment. Highlights trends, determining causes for unexpected variance
- Develops monthly, quarterly, and annual forecasts to accurately reflect current expectations of the business in collaboration with the CFO and other business leaders.
- Prepares and reviews on an ongoing basis the profitability of customers and business segments
- Provides support for treasury function to CFO and VP of Finance & Accounting
- Serves in other roles for Company as directed by CFO and broader executive team, opportunity for leadership and cross functional development (think Swiss Army Knife)

# Competencies, Education, Knowledge, Skills and Abilities

- Required Bachelor's degree in economics, business, mathematics, engineering, or other field demonstrating high quantitative and reasoning capabilities
- Minimum of 3 years relevant experience in economic modeling, FP&A, and/or investment banking or related discipline. Not all experience considered equal.
- Advanced level of expertise in MS Excel, MS PowerPoint, MS Word required. Attention to detail and accuracy a must
- Must be able to build a robust economic/valuation model "from scratch", and must be
  able to present the assumptions, methodology, and results in a clear and concise way in
  a management presentation (speaking from PowerPoint slides and MS Excel Model).
   This capability will be tested in the second round of interviews with a hands-on exercise
- Experience working in Oil & Gas industry and knowledge of upstream, midstream, and downstream fundamental business drivers preferred, but not required
- Must be willing to periodically work long hours in office setting, and to be flexible to work evenings and weekends when required by business
- Must be willing to travel monthly to other Texas business locations, and occasional to travel domestically in support of business. Typically, <25% travel
- This is not a remote position and must be willing to go into the office on a daily basis
